

OFFICIAL RULES: SKYLANDERS TRAP AND PLAY SWEEPS

NO PURCHASE NECESSARY TO ENTER OR WIN. SUBMISSIONS MAY NOT PROMOTE OR PORTRAY ANY ACTIVITIES THAT MAY APPEAR UNSAFE OR DANGEROUS TO YOURSELF OR OTHER PERSONS OR PROPERTY. 1. **SWEEPSTAKES TERM AND DEADLINES:** The "Skylanders Photo and Video Sharing Sweeps" (the "Sweepstakes") begins November 20, 2014 at 8:00 a.m. Pacific Standard Time ("PST") and ends December 11, 2014 at 11:59 p.m. PST ("Sweepstakes Period"). A random drawing of three (3) winners will be held from among all eligible entries received during the Sweepstakes Period. All entries received after December 11, 2014 at 11:59 p.m. PST will be ineligible for the chance to win a prize.

2. **ELIGIBILITY:** The Sweepstakes is open and offered only to legal residents of the 50 United States and the District of Columbia (excluding Puerto Rico and other U.S. territories and possessions), 13 years of age or older at the time of entry. During the Sweepstakes Period, tweet a photo or video of yourself or your child playing the *Skylanders* video game to @Skylanders including the terms #Skylanders and #TrapAndPlaySweeps (the "Entry"). Three (3) potential winners will be randomly drawn from the eligible entries received during the Sweepstakes Period. Limit of one (1) Entry per person/email address/household regardless of method of Entry. Proof of submission is not proof of receipt. If you post updates to or receive updates from Twitter via SMS from your wireless phone, your wireless service provider may charge you for each text message you send and receive. Please consult your wireless service provider for more information.

Sponsor is not responsible for any charges wireless service provider may charge entrant. Multiple entrants are not permitted to share the same Twitter account. Any attempt at e-mail or other method of Entry is void. Any attempt by any person to obtain more than the stated number of Entries by using multiple/different email accounts, or any other methods including, without limitation, script, macro or any automated or other means which subverts the Entry process, will void all of that person's entries and that person will be disqualified. Potential winners will be subject to compliance with these Official Rules and may be subject to verification of the Entrant's eligibility, including if winner is a minor, minor will be given an affidavit of eligibility and liability/publicity release and minor's parent or guardian must complete, sign and return all required documentation. Winner notification not acknowledged by Winner within twenty-four (24) hours after outreach from Sponsor may be forfeited at Sponsor's discretion and awarded to an alternate winner selected by Sponsor.
